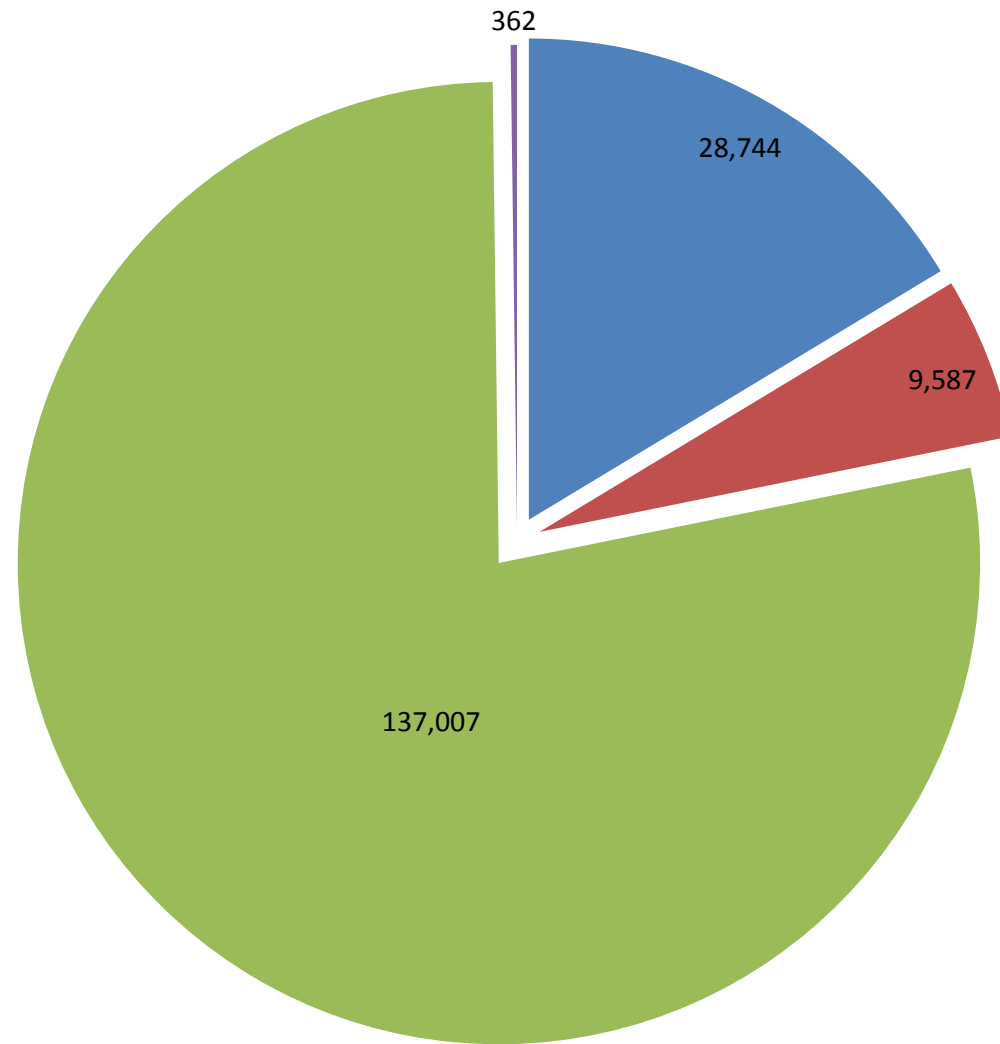

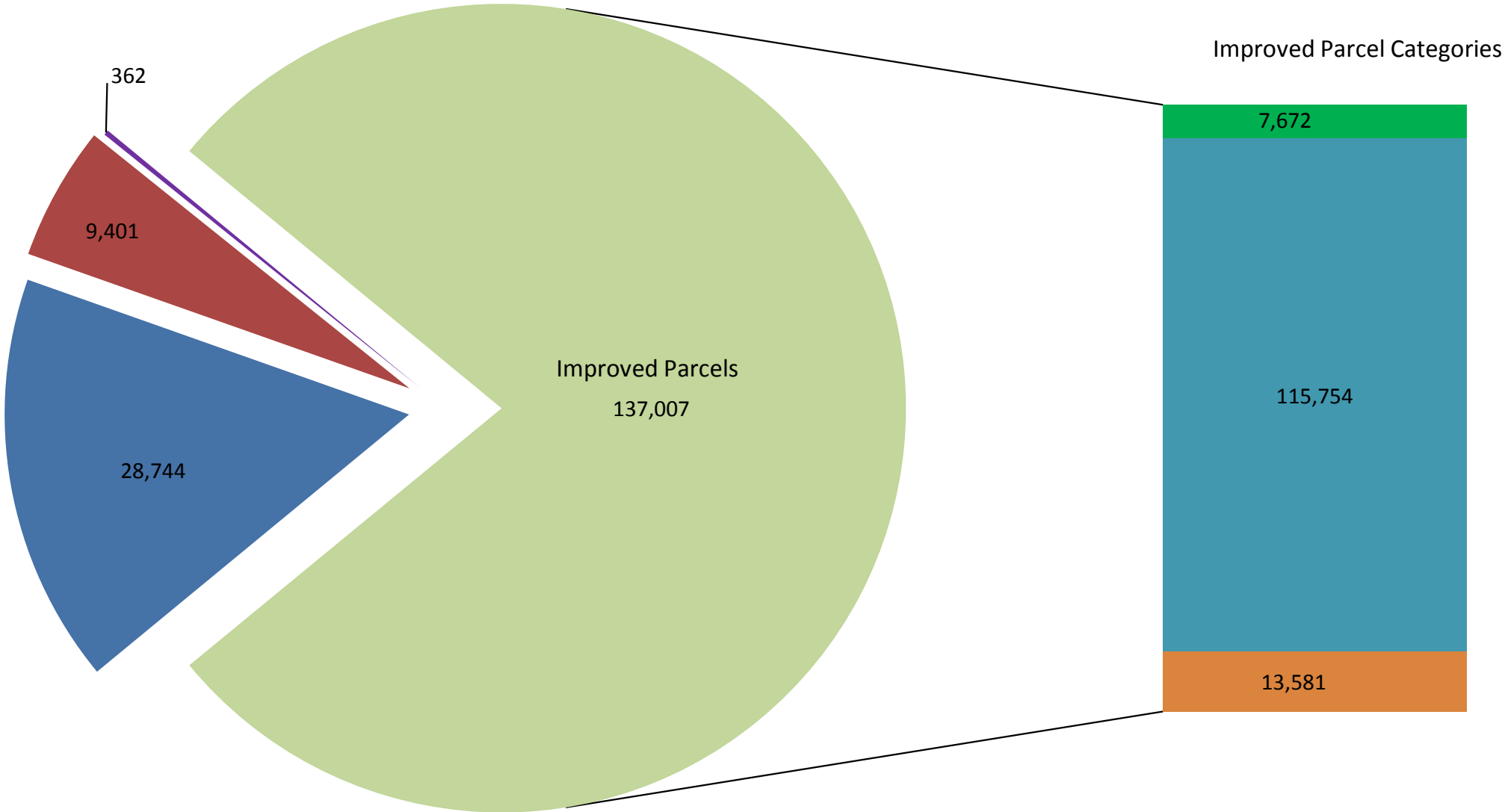

2015 Orleans Parish Parcel Count



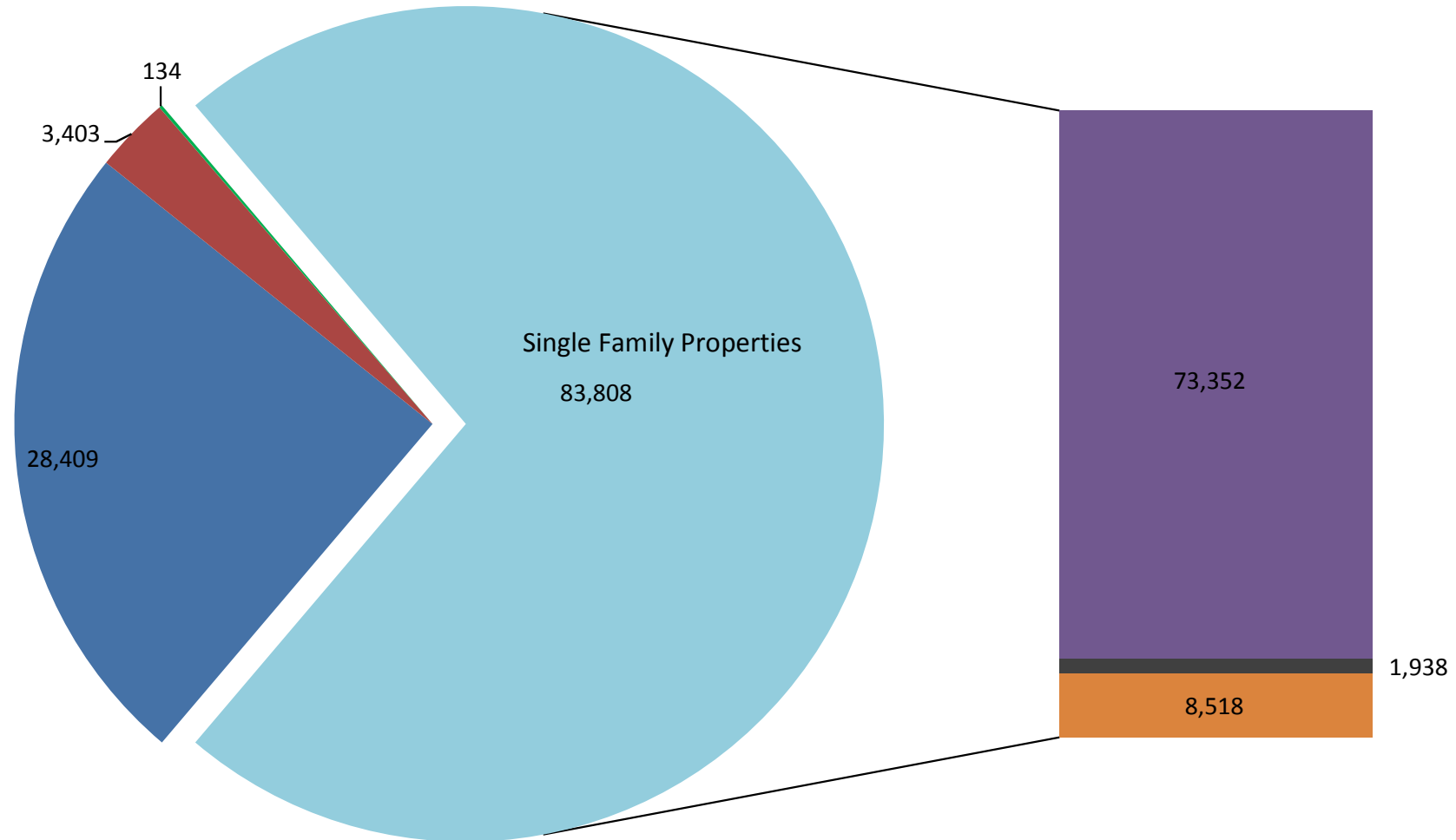
