Appeal on the Days Inn (Ralph Clifton) remains unresolved. Offer has been made to settle at \$836,539 arrived at by the income approach. Original value is \$1,004,581.

The debt service fee added to all exempt properties has been released by E&Rs done by our office. 131 total representing \$11,790.00 of fees.

Status of covenant renewals: 180 due to renew. 41 Have renewed so far.

The utility values came from DOR in December and could have been added to the 2016 digest, but were not. Values are down \$528,022 from 2015. Estimated tax loss of \$6,500 total to all tax districts.
