VI. 2011 Appeals: The Board acknowledged there are 14 of the remaining 2011 appeals in the review file pending Leonard's return to the office next week.

a. The 2011 appeals are being processed – at this time there are no 2012 appeals to present to the Board. *The Board acknowledged*.

VIII. Refund Requests:

a. Map & Parcel: 15-46

Owner Name: SHAW, LIGE RAY

Tax Year: 2011 & 2010

Owner's Contention: REFUND WAS NOT PROCESSED AFTER 2010 ARBITRATION

Determination:

1. On Thursday, 09/20/2012, this Office received a phone call from Mr. Shaw questioning why there had been no further action on his 2010 appeal following a decision set by an Arbitrator.

- a) For 2010 this property was valued at \$153,149.
 - \$25,505 Improvements
 - \$2,263 for 1 Non-covenanted acre
 - \$125,381 for 60 Covenanted acres
 - Average value per acre \$2,093
- b) Per Arbitrator's decision filed in Superior Court 03/10/2011 the value of the land for this account was set at \$91,500 (\$1,500 / acre). This resulted in a total property value of \$117,005 for 2010.
- 2. There is no record of any further processing (refund, etc) after the receipt of the above mentioned court order.
- 3. An "Authorization for Refund" for has been prepared for this account for the 2010 tax year.
- 4. For 2011 it appears that Mr. Shaw owes additional tax.
 - a) For 2011 Mr. Shaw applied for, and received, a local county homestead exemption, exempting the full taxable value of his dwelling and five (5) contiguous acres.
 - b) For 2011, the value of 10 acres was mistakenly exempted from the taxable value of this property.
 - Five (5) acres of land class 244 with a total FMV of \$9,910. The use of this acreage resulted in an exemption overage these acres were under covenant the exemption was for a greater amount than the acres were taxed on.
 - Five (5) acres of land class WP8.
- 5. For 2011 and forward, the 1V exemption has been refigured:

a) Exempting the one acre that is NOT under covenant

b) Exempting four covenanted acres contiguous to this one acre. (For more detail, please see the included map)

Recommendations:

1. Approve 2010 Refund Authorization and forward to Tax Commissioner.

2. Approve 2011 Not on Digest form and forward to Tax Commissioner.

 - i. Mr. Bohanon suggested there may be a need to draw up a letter for the Commissioner to consider the Assessor's Office is under budget and understaffed as well as the function of the office being behind and implementing furlough days for staff is going to slow progress even further.
 - ii. Ms. Gwyn agreed that the Assessor's office under budget and being understaffed and the need to train a new Field Representative indicates that all work days are needed.
 - iii. Mr. Barker, chairman discussed the budget as a whole is over spent and that the understanding is the Commissioner has no additional funds.

 The Board acknowledged and discussed above concerns.
