VIII. Appeals:

a. Map/Parcel: 64-101-A

Property Owner: Starkey, Sylvia

Tax Year: 2013

Contention: Filing an appeal for denial of local county senior exemption

Determination:

- 1) Applicants file indicates all exemptions except the local county exemption was approved.
- 2) The property owner should have received notification that the one exemption was not approved due to lack of income documentation.
- 3) There is no record of notice and no copy of a letter requesting the documentation from the applicant.
- 4) The applicant was given a copy of the appeal she filed on August 15, 2013 along with instructions to bring her income documentation by the appeal deadline of August 26, 2013.
- 5) Applicant brought in her 2012 tax return as income documentation on August 23/2013.
- 6) According to the return the total adjusted gross is above the limit to qualify for the local county exemption.

Recommendation:

Deny the local county exemption due to the applicant not being within the income limitations and send notification of Board action.

Contention:

- 1) Mrs. Kathy Brown Tax Commissioner visited our office and said Mrs. Hoskins came to her office and informed her that no one has lived in the house from before the first of the year till now.
- 2) Also, she said that Charles Hoskins has been deceased from before the first of the year. She indicated the homestead exemption should be removed from this record for tax year 2013.

Determination:

- ii. Research of death records online were unsuccessful, however Ms. Kathy reported that Mr. Hoskins is deceased.
- iii. Notices of value with the homestead applied have been sent

Recommendation:

Requesting Board approve removing homestead and correcting tax bill.
