- 2. Appellant's case is based on purchase price.
  - a. Per included e-mail received 12/17/2013, interior is in good condition
  - b. Vehicle was not available for inspection by the Assessors Office, but the single photograph provided by the Appellant does not indicate any body damage.
- 4. The TVAT is NOT a sales tax; therefore the actual selling price may not be significant in determining its value for tax purposes.
- 5. For used vehicles O.C.G.A. §48-5C-1(a) 1(A) sets the Fair Market Value as the value in the State's Assessment manual.
