VI. APPEALS:

a. Owner: Emily Hennon

Vehicle: 2000 Toyota Camry

Tax Year: 2015

Owner's Contention: Condition, engine blown, value of car. I would say due to condition \$250.00 is what the car is worth,

Determination:

- 1. The mileage on the vehicle was Exempt at the date of purchase.
- 2. The purchase price according to the bill of sale is \$400.00 from Complete Cash Holdings LLC.
- 3. The Vehicle is a 2000 Toyota Camry in very poor condition. (See pictures in file)
- 4. The State value is \$2,450.
- 5. The NADA based on 200,000 miles shows clean retail as \$3,750, clean trade in as \$2,025, average trade in as \$1,500, and rough trade in as \$850.
- 6. Kelley Blue Book based on 200,000 miles shows fair purchase price as \$1,454 and the low trade in range is \$430. The values are based on fair condition (Kelly Blue Book does not give values for poor condition vehicles).

7) Property owner presented an invoice where she purchased a 1998 Toyota Camry for \$950 for the motor to go in the 2000 Camry in question.

Recommendations: Even though the Owner's contention is the car is only worth \$250 (scrap value), I recommend averaging the NADA rough trade in of \$850 and the Kelly Blue Books low trade in range of \$430 for a value \$640 and issue a refund for the difference.

Determination:

1. Please see included BoA Agenda Item for 05/27/2015 meeting of the Board for background.

- 2. The Appellants are, per OCGA §48-5-380, requesting a refund of overpaid taxes for tax years 2013 to 2003.
- 3. As was noted in the 05/27/2015 Agenda Item, this tract was appraised at 3 acres, actually it less that 1 acre (0.81).
 - a. The parcel was acquired by the Appellants in March of 2002.
 - 1. For 2002, this parcel was a nine acre tract owned by Winston C & Kathryn Pledger.
 - 2. For 2003, the parcel was transferred to the Appellants and split into two parcels: 19--3 on the east side of Josh Ward Rd and 19--3-C on the west side of John Ward Rd
 - b. Parcel 19--3 has been erroneously listed as three acres since 2003.
- 4. Per OCGA §48-5-380(b) is limited to 3 years.

Recommendation:

- 1. Approve authorization for refund for tax years 2013 to 2011.
- 2. Refer Appellants to County Commissioner for any additional relief.
