VI: MISC ITEMS

a. 2017 Public Utilities

The 2017 Public Utility valuation and notice packet has arrived from the Department of Revenue. I am in the process of preparing the notices to be mailed to each of the Utility companies. Part of the preparation involves the "equalized ratio" for tax year 2017.

Last year (tax year 2016) the board set an equalized ratio of 36.95% based on the Department of Audits ratio study with updated 2015 tax values and corrected sale prices for a ratio of 36.95%.

Before the 2017 notice of assessments for public utilities can be completed I will need to know the following:

- 1. Does the board want to adopt the Department of Audits ratio of 36.69%?
- 2. Does the Board want to use the "in house" sales ratio study based on all 2016 sales with a ratio of **36.17%?**

Recommendation: After consulting with Kenny Ledford, it is my recommendation to use the department of Audits ratio of **36.69%** for 2017.
