Lack of independent validation / verification of Mobile Home values and/or Mobile

Home option values.

Determination:

- 1. The county needs a set of valuation schedules for manufactured homes similar to those currently used for aircraft and marine craft.
 - a. For use in manufactured home appeals.
 - b. For use as source material for cost data for manufactured home option values.
 - House style roofing and siding
 - Central Air systems
 - Heat systems / gas and electric
 - Bay Windows / Box Windows
 - Fireplaces / Wood Stoves
 - Etc.
- 2. In the past the county used the NADA mobile home valuation schedules on CD.
 - a. Two years ago NADA stopped producing the CD Rom.
 - b. The County then subscribed to the NADAGuides website
 - c. For 2017 the subscription has expired.
- 3. Our values for 2017 are required to reflect FMV as of January 1st of the tax year.
 - a. For a \$65 subscription, NADA values for January 2017 are available on the web.
 - b. It is a 12-month subscription, but at the reduced cost, only the January-February values will be available.

Recommendation:

It is recommended that the Board of Assessors approve the expenditure of \$ 65 for the subscription cost to the NADA January 2017 mobile home valuation guides.
