Owner Name: S32-55

Tax Year: 2018

Owner's Contention: Requesting Board of Assessors review appeal and consider new supporting information presented. Mr. Cook stated a possible costly environmental study would be necessary if he were to sell the property.

Owners Asserted value: \$275,000

Determination:

1. 2018 appeal was presented to the Board of Assessors by Roger Jones on 7/25/2018 with recommendation of no change. The property is valued at \$565,558.

- 2. Mr. Cook presented an appraisal on Monday, September 17, 2018 from 2013 from Hunt and Associates for \$237,500.
- 3. The property was appealed to the Board of Equalization for 2012, 2013, & 2014 and the value was set at \$225,000.
- 4. The property was appealed again in 2015 and the Board of Equalization set the value to \$225,000 for 2015, 2016, & 2017.
- 5. The property is being leased for \$2,500 per month.

Recommendations: I would like the BOA's direction on how to proceed with the appeal.

c. Map & Parcel: 41-10-1

Owner Name: Mohawk Industries, Highway 114 location -- PP: Furniture, Fixtures and

Equipment

Tax Year: 2018

Owner's Contention: Requesting the Board of Assessor's review the new supporting documentation pertaining to equipment in wrong classification group and consider a decrease in depreciation factor for the idle equipment listed.

Determination: Total reported cost value \$15,983,111 is originally assessed at \$5,142,277. Property owner's requested assessed value is \$2,421,228; a difference of \$2,721,049.

- 1. Computer Equipment -- There is \$174,030 in value recorded in group 2 that should be in group 4; which means the equipment depreciation is not calculated by the correct factor, therefore not allowing the correct depreciation.
 - a. This equipment is backing guidance system/computer equipment currently depreciating with a factor of .34 in group 2. The depreciation factor for group 4 is .10 for 2010 peripheral computer equipment.
 - b. Group 2 calculation -- \$174,030x .34=\$59,170 original returned
 - c. Group 4 calculation -- \$174,030x .10=\$17,403 difference of \$41,767
 - d. The original cost totaling all equipment is \$15,983,111 assessed at \$5,142,277. With the adjusted computer equipment re-grouped as class 4 would indicate a total of \$15,809,081(cost) -- a total assessment of \$5,100,510 for all equipment.
- 2. Idle Equipment -- The property owner is requesting the remaining equipment's depreciation factors be adjusted due to the equipment being idle, not operable or obsolete.
 - a. Excluding the computer equipment (\$17,403), the remaining idle equipment asserted assessed value is \$2,403,825.
 - b. It is standard procedure to follow State of Georgia depreciation factors for any and all equipment and is outside the guidelines of the Board of Assessor's to adjust these tables.
 - c. The Board can however adjust the historical cost if data is available -- market data or documentation to trend the original cost for economic obsolescence or functional obsolescence.

Recommendation:

- 1. Correct the classification to group 4 for backing guidance computer equipment for \$17,403 a value of \$15,809,081 for equipment (with Freeport exemption of \$30,580,703 in inventory).
- 2. Leave the idle equipment as originally assessed due to no supporting market data or a trend analysis for observable tendency of economic behavior for a total property value of \$49,542,916.
