V: MISC ITEMS

a. 2019 Public Utilities

The 2019 Public Utility valuation and notices have arrived from the Department of Revenue. I am in the process of preparing the notices to be mailed to each of the Utility companies. Part of the preparation involves the "equalized ratio" for tax year 2019.

The Department of Audits Sales Ratio for the 2019 tax year is 36.46%. This is based on 2018 sales.

Last year (tax year 2018) the board adopted an equalized ratio of **36.34%** based on the Department of Audits Sales Ratio Study with 2017 sales prices.

Before the 2019 notice of assessments for public utilities can be completed I will need to know the following:

- 1. Does the board want to adopt the Department of Audits ratio of 36.46%? If this ratio is adopted the Utility Companies will appeal to the Department of Revenue.
- 2. Does the Board want to use the "in house" sales ratio study based on all qualified 2018 sales with a ratio of 39.60%? If this ratio is adopted the Utility Companies will appeal to the Board of Assessors.

The 2019 in-house Sales Ratio study based on 2018 sales was presented and approve by the Board of Assessors on June 5, 2019. The ratio approved was 39.60%. Below is a comparison of the Utilities using 36.46% and 39.60%:
