Owner's Contention: Home is in very poor condition.

Owner's Value Assertion: \$4,154

**Determination:** Home is in poor condition. Home is uninhabitable. Electrical system is non functional. The floor has areas of damage and sagging or falling in. Roof appears to have leaks.

Recommendations: I recommend applying a sound value of approximately \$5 per sf. for an

improvement value of \$3,944 and TFMV of \$7,149.

Owner's Contention: Requesting Freeport exemption of \$1,838,212.

#### **Determination:**

- 1. This company manufactures wire harnesses; located at 3567 Highway 48 and is requesting Freeport exemption for raw materials, goods in process and finished goods in the amount of \$1,838,212.
- 2. A 2019 return and Freeport application was submitted indicating a total inventory and machinery and equipment value of \$2,695,058 after correcting the value amount for supplies.
- 3. There is a taxable amount of \$855,346 in furniture, fixtures, equipment and \$1500 in inventory not eligible for Freeport.
- 4. This company received Freeport exemption in tax year 2018.

**Recommendation:** Suggesting the approval of Freeport exemption in the amount of \$1,838,212 for tax year 2019 in accordance with 48-5-48.2.

b. Map & Parcel: Account # 208/Map T12-61 at Mount Vernon Mills

**Owner Name: DIVERSITEX** 

Tax Year: 2019

Owner's Contention: Requesting Freeport exemption of \$52,605.

#### **Determination:**

- 1. This company is a textile wholesaler with bill and held inventory at Mount Vernon Mills and is requesting Freeport exemption for finished goods held less than 12 months in the amount of \$52.605.
- 2. The \$52,605 in inventory is also the amount reported by Mount Vernon Mills.
- 3. A 2019 return and Freeport application was submitted indicating a total inventory value of \$111,926.
- 4. There is a taxable amount of \$59,321 in inventory not eligible for Freeport.
- 5. This company received Freeport exemption in tax year 2018.

**Recommendation:** Suggesting the approval of Freeport exemption in the amount of \$52,605 for tax year 2019 in accordance with 48-5-48.2.

c. Map & Parcel: Account # 806/Map 50-58-G Owner Name: VITALITY LABS LLC

Tax Year: 2019

Owner's Contention: Requesting Freeport exemption of \$78,017.

## **Determination:**

- 1. This company is a diet supplement manufacturer located on Vitality Lane off of John Bankston Dr, Summerville and is requesting Freeport exemption for raw materials and goods in process in the amount of \$78,017.
- 2. A 2019 return and Freeport application was submitted indicating a total furniture, fixtures, equipment and inventory value of \$90,357.
- 3. There is a taxable amount of \$12,340 not eligible for Freeport after correcting the supplies in inventory.
- 4. According to tax records, this company was added to records in 2017 and did not apply or receive Freeport in 2018.
- 5. In accordance with O.C.G.A. 48-5-48.1 and 48-5-48.2 and in reference to the Department of Revenue guides and corresponding with Personal Property leaders, this company qualifies for Freeport exemption.

**Recommendation:** Suggesting the approval of Freeport exemption in the amount of \$78,017 for tax year 2019 in accordance with 48-5-48.2.

d. Map & Parcel: Account # 234/Map 50-44

Owner Name: ESPY PUBLISHING COMPANY

Tax Year: 2019

Owner's Contention: Requesting Freeport exemption of \$22,300.

#### **Determination:**

- 1. This company is a newspaper printing company located off Highway 27 in Summerville and is requesting Freeport exemption for rolls of paper and ink in the amount of \$22,300.
- 2. A 2019 return and Freeport application was submitted indicating a total furniture, fixtures, equipment and inventory value of \$141,742.
- 3. After discussing with the company's accountant/representative that further research of Georgia Code and department head assistance would be required to determine eligibility, they decided to apply by the deadline of April 1 to see if they were eligible.
- 4. According to O.C.G.A. 48-5-48.1 and 48-5-48.2 and in reference to the Department of Revenue guides and corresponding with Personal Property leaders, this company does not qualify for Freeport due to the following:
- The company buys their rolls of newspaper and does not manufacture the paper themselves
- They buy the barrels of ink; it is not manufactured at their business
- They are printing newspapers; this is not considered manufacturing
- They retail the newspaper; it is a final level transaction (example: no different than a magazine company or a cabinet maker making custom cabinets for someone's home)

**Recommendation:** Suggesting the denial of Freeport exemption in the amount of \$22,300 for tax year 2019 in accordance with 48-5-48.2.
