b. Subject: Personal Property 3 year review updates Tax Year: 2021

- 1. All commercial personal property files and records have been checked for correct data and desk audits or reviews conducted beginning October 2018 to August 4, 2021. New businesses and accounts with issues not resolved by desk audit have been visited.
- There are 11 accounts being sent a second audit letter that have not filed a return or submitted any documentation even after an on-site visit and leaving a return form in person. According to the Department of Revenue and Appraiser Procedure Manual for personal property, these accounts have been given a value based on the best information obtainable.
- There are 26 tax generating business accounts with a 10% penalty for not filing returns in 2 years or more and the marine accounts are currently being audited for the same procedures to apply. This is implemented in accordance with State law and the Department of Revenue's recent audit of our County.
- Attempts have been made to contact by phone and letters or on-site visits to all these businesses in order to resolve any issues and give them the opportunity to comply. Only 11 out of the 26 were

unsuccessful to get at least some information; the remaining 15 business owners indicated they would send their returns in 2022 and have given me some information recently.

- 2. We have 613 commercial accounts currently on record; 43 new accounts were added in 2021, 157 total either added or had ownership changes since 2018 when the 3 year audit cycle began. These are not just store front business openings but companies leasing to businesses, 3 part ownership accounts, out of state companies with goods being held in local businesses; everything from heavy machinery or under-ground gas tanks to copiers to Krispy Kreme donut displays. Letters and reporting forms are mailed to all new accounts, then the regular cycle of mailings to all other accounts.
- 3. We have 37 industrial accounts; all have been checked for accurate data. There are eight accounts holding inventory at Mount Vernon that did not file a return in 2021. Currently there are three with no value, one of which has not responded to letters or calls but all are keeping taxes up to date.
- 4. There are 36 exempt accounts that have all been checked for data accuracy and estimated values added to those with no value.
- 5. For 2021 tax year there were 112 boats added and one airplane. All marine accounts have been checked for basic data accuracy and ABOS values applied according to the information received from the Department of Natural Resources (DNR). There are seven tax generating marine account owners that have not filed a reporting form.
- •Letters and reporting forms were mailed to all new marine accounts, then the regular cycle of mailings to all other accounts.
- •We have 624 marine accounts; some have more than one water craft giving us a total of 780 watercraft on record. The on-site visits for boats are accounts with issues which usually the property owner's do respond with purchase documents, bill of sale or a reporting form before a visit is necessary.
