IX: PERSONAL PROPERTY a. SUBJECT: Boat Trailer Values

Tax Year: 2022

Suggestion: Department of Revenue suggest applying ABOS values to boat trailers

Determination:

- 1. Many ABOS boat values in our records include trailer values; the trailer values must be subtracted out due to them being taxed separately.
- 2. In the past, these trailer values have been researched different ways and a value subtracted, which was not against Georgia law, however; the D.O.R. representatives provided us with an ABOS guide specifically for trailer values.
- 3. These ABOS trailer values are now being applied using the average retail value if the specifics of the make, model and size are not known.

Recommendation: Suggesting the Board of Assessors approve using the ABOS trailer value guide provided by the Department of Revenue to maintain a better form of uniformity for property owners.

b. Subject: Watercraft and boats registered in Georgia; kept out of state Tax Year: 2022

Determination:

- 1. We have boats on record, 6 of them are above the \$7500 cap, that are registered in Georgia provided to us from the Department of Natural Resources, however; they are kept in other states.
- 2. The State mandated marine reporting forms indicate on page 2's instruction sheet that the boats need to be returned to the county where they are located 184 days a year or more.

3. According to discussion with our Personal Property D.O.R. representative, if a boat is registered in Georgia, it should have an account on record. (This does not mean it has to be taxed if kept out of the county more than 184 days of the year with documentation provided).

Research:

- 1. In the past it was standard procedure to delete boat accounts from our records even if they're on the DNR listing as long as the owner provided documentation or some form of proof of where the boats are kept.
- 2. This method cleared out accounts so they did not receive reporting forms in the old data base system.
- 3. With the current database system and upon doing research and reviewing the entire marine accounts' methods, the old methods have become obsolete.
- 4. The boats previously deleted are in the process of being added back to records and sent a return form as long as they appear on the Department of Natural Resource's list.
- 5. According to surrounding counties, they handle this issue different ways, but as long as some form of documentation is provided by the taxpayer of the boat kept out-of-state, they are not taxed.
- 6. One method is to keep the account on record as suggested by the D.O.R. representative and according to research of other surrounding WinGap counties, then apply a \$0 value so they are not taxed.
- 7. One issue is requesting the owners provide a tax bill statement that they have paid taxes on the boat where it is kept. (A boat registered in Georgia, if it's kept in Alabama, there is not yearly tax, and therefore this documentation does not exist)
- 8. Only if it's registered in Alabama, it's taxed in Alabama, therefore surrounding counties have been accepting different forms of documentation such as the address information, photos of where it's docked and the taxpayer's signed statement.

Recommendation: Suggesting out-of-state boats be kept on record, apply \$0 value to those above \$7500 as long as they provide documentation so they will not be taxed.
