No agreement was reached.

h. Allen Appeal to Superior Court

Mr. Allen and the BOA agreed to a value of \$2,115.

i. Hill Appeal to Superior Court

Mr. Hill stated at the beginning of the conference that this was just a stepping stone to go on the Superior Court. The BOA offered a value of \$787,000, a reduction of \$40,600. Mr. Hill rejected the offer, so no agreement was reached.

j. Moeller Appeal to Superior Court

Mr. Moeller's original asserted value was \$187,930. During the conference, he increased that value to \$207,544. The BOA offered a value of \$241,890, a reduction of \$13,000.
