# VII: EXEMPT PROPERTY

a. Owner Name: Rast, Phillip

Real Property Map & Parcel: 29-6-A; 29-60-B; 40-95

Tax Year: 2025

**Contention:** Requesting exempt status for three properties (Red Clay Ranch) **Determination:** 

- 1. The owner has three parcels of real property which he's requesting exempt status approval.
  - The three properties are for Red Clay Ranch Equine Horse Rescue and Sanctuary; among the three is map/parcel 29-60-A the owner's residence. (See attached applications)
  - He has submitted the 501c3 file numbers on his applications and can provide the documentation.
  - All three properties have been approved for the agricultural covenant exemption. (See attached PRC's)
- 2. Research has been conducted as follows:
  - Course material provided by the Department of Revenue (Exempt Procedures Workshop) which references O.C.G.A. § 48-5-41 Exempt Property
  - D.O.R. rules and regulations Chapter 40-29 (Georgia Agricultural Tax Exemption- "GATE")
- 3. According to research and the way the law is interpreted, although exempt from federal income tax, the property does not qualify for exempt status.
  - (See attached) O.C.G.A. § 48-5-41 and Department of Revenue Rules and Regulations 40-29-.01 (3) filed through December 18 2024.
  - Other research pertaining to property owners in the State of Georgia who have questioned online attorneys about this subject resulted in the owner being required to submit extensive documentation along with the 501c3 filing to an attorney for legal advice.

**Recommendation:** Recommending the Board of Assessor's review documentation and deny the applications at this time, based research of laws and research indicating the property owner obtain legal advice.
