a. Owner: Clark, James H Map/ Parcel: 53-29 Tax Year: 2025

Owners Asserted Value: \$1,000

Owner's Contention: No heat, no air, no water, roof damage, siding damage covered with metal, deck in bad condition. It is used for storage.

Appraiser Notes: Property is located at 8641 Highway 100, Lyerly, GA, with mobile home value of \$18,815.

#### **Determination:**

- 1. This is a 1990 20x48 double wide Mobile home that has add-ons for a roof, siding and a deck.
- 2. Mobile homes are set by NADA values; this mobile is set at fair condition under NADA values.
- 3. The property was reviewed on February 28, 2025, for appeal.
- 4. After review of the mobile home; the condition of the roof, siding and deck was reduced resulting in a total NADA value of \$16,155.

**Recommendation:** Recommending a decrease in value for the mobile home from \$18,815 to \$16,155 for tax year 2025.
