TO SEARCH BY PARCEL NUMBER (AKA PARID - AKA TAX MAP KEY)

OMIT THE FIRST '4' – THE ISLAND JURISDICTION AND ENTER 12 DIGITS WITHOUT DASHES.

(If you are entering from a Tax Bill – please also OMIT the LAST 3 ('Owner Sequence' digits)

And again you can enter a parcel numeric string to get a list (here we entered '24001' in Parcel Number field)
