If any information is different or has changed as of January 1, please mark it on the sheet. If the lot is empty/vacant, please write this on the sheet.
- 3.) You have also been provided with blank sheets. If you have any new mobile homes in your park, this is the form you should list them on. Use these blank forms to inform us of any mobile homes not listed on your pre-printed sheet.

Please notify the owners in your park that there are several tax exemptions that they may be eligible for.

- 1.) Homestead Exemption: The owner must be 65 years of age or older (Or turning 65 in that tax year). They must own, occupy, and maintain the residence. It must be their primary residence and they can only receive ONE exemption. They will need to provide a driver's license or state issued ID or birth certificate to apply.
- 2.) Disability Exemption: The owner must be totally disabled during the year they are applying in. They must own, occupy, and maintain the residence. It must be their primary residence and they can only receive ONE exemption. They will need to provide proof that they are classified totally disabled under a program authorized by the US Government or by any retirement system (example Social Security or VA). They must apply by December 31 to receive this exemption.
- 3.) Military: ACTIVE DUTY Military owners that own a mobile home or vehicle in KY may be exempt from property taxes if they claim another state as their home of record. They will need to provide a January LES for that tax year proving that they do NOT claim KY. They must be living in the eligible Mobile Home.
