- 5. FINAL APPROVAL ON SEPTIC TANK PAPER (IF NEW)

****ALL MOBILE HOMES MOVING IN & OUT OF THE COUNTY MUST BE 1976 OR NEWER****

STEPS:

- 1. COME TO THE ASSESSOR'S OFFICE ROOM #309 WITH THE PAPERWORK FROM A, B, C, D, E OR F LIST ABOVE.
- 2. IF TAXES NEED TO BE PAID, WE WILL PROVIDE THE INFORMATION FOR YOU TO PAY YOUR TAXES WHETHER IT BE CURRENT OR ADVANCE.
- 3. THEN GO TO #303 PLANNING OFFICE TO GET APPROVAL FOR PROPERTY REVIEW CHECKLIST.
- 4. THEN COME BACK TO ROOM #309 ASSESSOR'S OFFICE TO PURCHASE DECAL.
- 5. ONCE YOU ARE FINISHED WITH THE ASSESSOR'S OFFICE, YOU WILL NEED TO GO ROOM #303 TO UPDATE YOUR ADDRESS.
- 6. FINALLY, IF YOU ARE PAYING FOR AN INSPECTION, YOU WILL NEED TO GO TO CODES ENFORCEMENT NEXT DOOR TO E-911 ADDRESSING.
